I UNDERSTAND AND AGREE:

- I must submit the Application for Admission, Application Fee (\$75.00 USD) and all required supporting documentation by the appropriate deadline dates, if I am to be considered for admission.
I must submit a TOEFL score of 550 with section scores no lower than 50, or computer based TOEFL score of at least 213. I understand that the TOEFL (or other proof of English proficiency as outlined in the university catalog) is required of all students whose native language is not English. Photocopies of test scores will not be accepted.
I must make my own arrangements for transportation and housing.
I must present satisfactory evidence of coverage under a major medical health insurance plan, including medical evacuation and repatriation coverage, or agree to pay for university-sponsored insurance before I will be permitted to register. Waiver forms for insurance through UHCL must be submitted by the semester's census date.
If I am considered for admission, I will provide any remaining official final year mark sheets and/or test scores prior to being allowed to register for any courses.
All preparations will be made to attend New International Student Orientation; I am responsible for obtaining the information disclosed at the orientation.
If I enroll at the University of Houston-Clear Lake, I will abide by all the policies, rules, and regulations governing student and academic affairs.

Additionally, F-1 students:

- My sponsor must have at least \$20,900.00 USD available for each year of study at the University of Houston-Clear Lake, and that I must have at least \$7,000.00 USD in my possession to cover initial expenses when I arrive at UH-Clear Lake to begin my first year of study.
I must seek authorization from my International Student Advisor prior to dropping below full time status; failure to do so will result in being out of F-1 status with immigration.
I must enroll full-time each fall and spring semester (undergraduates must enroll in 12 credit hours; graduates must enroll in 9 hours). Enrolling in more than 3 credit hours of web bases/online courses per semester will not be counted toward full time enrollment.
I must be in Houston in time to register for classes on or before the date specified on my SEVIS I-20 (F-1) or DS-2109 (J-1).
I will accept visa restrictions that prohibit any unauthorized off-campus employment.
